Terms and Conditions**

1. Information on how to enter forms part of the terms of entry. Entry into the promotion is deemed acceptance of these terms and conditions.
2. Entry is open to all residents of Australia who are/become a Supercheap Auto Club Plus member, Supercheap Auto Trade Direct customer and/or Club BCF member and can take the prize between 11th June 2021 and 14th June 2021 (inclusive). However, employees and their immediate families of Super Retail Group Pty Ltd, Red Bull Australia Pty Ltd, competition partners (Mitsubishi Motors, Chameleon, Can-Am, KTM, BFGoodrich and Method Race Wheels), Engage Interactive, and their associated agencies and companies are not eligible to enter.
3.
