

“BRONCOS VEGAS” PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents aged 21 years or over.
3. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. Entries into the promotion open on 03/02/24 and close at 11:59PM AEDT on 11/02/24 ("**Promotional Period**").
5. To be eligible to enter, individuals must, during the Promotional Period, complete the following steps:

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
8. Incomplete or indecipherable entries will be deemed invalid.
9. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

The judges may select additional reserve entries which they determine to be the next best, and record them in order, in case of an invalid entry or ineligible entrant. Winner will be notified by Facebook direct message on 13/02/24 at 10AM AEDT. Winner must respond to this direct message by 11:59PM AEDT on 15/02/24 in order to be a valid winner. If the winner does not respond within this timeframe, the prize will be forfeited and be awarded

to a reserve winner. For clarity, the reserve winner will until 11:59PM AEDT on 16/02/24 to respond to the direct message else they will forfeit the prize.

Without limiting any other terms herein, the entrant agrees to indemnify the Promoter for any breach of the above terms.
